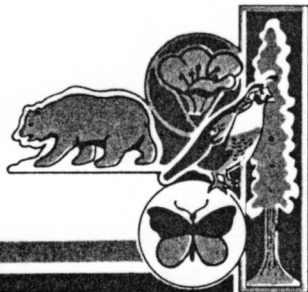

ARTICLES OF INCORPORATION  
OF  
THE ESCONDIDO CREEK CONSERVANCY

JUN 14 1991

MARCH FONG EU, Secretary of State

ONE: The name of this corporation is THE ESCONDIDO CREEK CONSERVANCY.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are the preservation and enhancement of open space lands located within the watershed of Escondido Creek and surrounding areas for educational, scientific, ecological and scenic opportunities.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is Martha L. Blane, 19828 Fortuna del Este, Escondido, California 92029;

FOUR: (a) This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 180(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

(b) On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit

fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
