President's Message Spring in the "Elfin Forest" - Time to take a hike!

Elfin Forest is the name that is used to describe the chaparral and coastal scrub vegetation that once covered most of Southern California. In the last 20 years, a coalition of public and private entities, including The Escondido Creek Conservancy (TECC), have worked together to protect thousands of acres of this critically endangered habitat. Today the Escondido Creek watershed has one of the largest protected tracks of virgin "Elfin Forest" in California and the US.

That's a great conservation story, but to really understand what a treasure we have in North County I urge you to get out and take a hike in Elfin Forest this spring. I recommend the Elfin Forest Recreational Reserve with over 11 miles of trails - don't forget to stop by the



Interpretive Center before your hike and see what the creative docents have on display. The Interpretive Center at the Reserve on Harmony Grove road is a joint project of TECC and the Olivenhain Municipal Water District. There's always something new on exhibit at the Interpretive Center for the kids and families. There's no better way to celebrate Earth Day than a few hours of stewardship. Join us this Earth Day on April 14th from 9 a.m. at the Reserve for a morning of activities for the whole family. Also in April, "Bill the Bug Guy" will present "The Amazing Insect Kingdom - Up Close!" on Saturday, April 21st, from 10 a.m. to noon at the Interpretive Center.

News from the Elfin Forest Interpretive Center

“THAT WAS AWESOME” was the comment as the black fly larva transformed into an adult on the video microscope.



“I liked tearing apart owl pellets and figuring out what animal the owl had eaten. It was gross, but cool.” These are just some of the comments of Oak Hill Elementary students on their recent field trip to the Elfin Forest Recreational Reserve. This winter over 300 elementary

school students are part of a watershed education program through a partnership with the San Diego Zoo and the Olivenhain Municipal Water District, which provides a hands-on experience in nature through a grant and TECC funds.

We appreciate the vital support over the past two years from The Charles H. Stout Foundation and The Erik Baumgartner Memorial Fund that has enabled TECC to provide science equipment, materials, and training for this program. These funds, by giving us potential matching money, have also enabled TECC to apply for larger grants. TECC recently submitted a grant to the National Fish and Wildlife Foundation with the San Diego Zoo and Eco-Life to focus on continuing our school-based program.

With the increased number of visitors to the Interpretive Center and Reserve, it is our goal to provide quality experiences to everyone. Land Preservation Success - Deer Park Ridge Now Protected from Development! by Ron Forster, Chair, Communications Committee

There is a tranquil chaparral valley in northeast Escondido where the birds are singing, the mountain lilacs are blooming, and a family of bobcats are roaming just as they have for thousands of years. It is the valley that the Deer Park Zen Buddhist Monastery shares with its neighbor to the west and is the valley adjacent (west) to Daley Ranch. Out of this valley flows a seasonal stream that connects with Reedy Creek and from there into Escondido Creek. The water from this valley will remain clear and the slopes of this valley will remain natural thanks to the love and support of the community.

Three years ago bulldozers began to grade housing sites at the top of the valley as the land owner prepared to sell the hillside for development. A group of volunteers began to look for a way to protect this land and save one of the few undeveloped valleys left in the region. TECC provided guidance and support which led to an agreement between the land owner and Deer Park Monastery to protect the land.

The 120 acre hillside was part of a total of 220 acre set of two parcels originally appraised at a total price of \$3.5 million. No land protection funding was available, and private funding could not be found to achieve the asking price. Through several years of negotiation and fund-raising, a solution was found to protect the hillside. The land owner agreed to grant a view-shed easement for the 120 acres that would preserve the natural habitat. Over 400 donors contributed to raise the \$450,000 in funds and loans needed to achieve this. TECC was a major contributor providing \$8300 in donations from a fund-raiser held for the project. On March 2nd the agreement was signed with the landowner.

Fundraising is continuing to pay back the remaining no-interest loans that were required to complete the project. Negotiation is also continuing to find a solution to protect more of the 220 acre property. Please contact TECC if you would like to support the effort.

If you would like to experience this beautiful valley, you are welcome to come out to the Deer Park Monastery on most Sunday mornings beginning at 9:00 a.m. for an outdoor walking meditation as part of their public day of mindfulness. Stay for as much of the day as you like and enjoy walking on the trails and experiencing the tranquility of this natural setting.





The Escondido Creek Conservancy Monitors Creek Water Quality

Escondido Creek runs from the upper headwaters in Bear Valley above Lake Wohlford, more than 26 miles to meet the ocean. In the City of Escondido the creek has been channelized to prevent flooding of city neighborhoods, but through the canyon shared by Harmony Grove Road, where it runs through the Elfin Forest Recreational Reserve, it is unfettered, running through coastal sage scrub with sycamore and oak trees. It continues south through the canyon east of Paint Mountain to the ocean at the San Elijo Lagoon in Cardiff. Much of the water volume that we see in the summer is from irrigation and other runoff that enters the storm drain system. When it rains the creek carries direct runoff from the rainfall. In order to maintain a healthy ecosystem, the water needs to have minimal contaminants. TECC, therefore, has established a water quality team including both TECC members and other community volunteers, to monitor the water quality in the creek over time and establish a baseline of data.



The program oversees implementation of watershed management planning, educational initiatives, and legislative efforts benefiting the San Diego regional watersheds. The TECC Water Quality Committee with the help of Paul Curtis, a fish biologist and committee member Greg McBain, a docent at the Elfin Forest Recreational Reserve Interpretive Center, has installed equipment to measure daily water temperature. Monthly samples are also being collected for pH, dissolved oxygen, nitrate, and other water quality parameters important to ecosystem health. The graph shows temperature data collected during 2011 up near the creek crossing at Country Club Road.
